RECORD OF PROCEEDINGS
FOR THE GOVERNING BODY OF THE
TOWN OF WHEATLAND

A special meeting and a public hearing of the Town Council for the Town of Wheatland, Platte County, and State of Wyoming was held in the Council Room of Town Hall on Monday, June 19, 2018 pursuant to the law.

Mayor Fabian called the Budget Hearing to order at 7:00 p.m. Discussion was held on changes to the Budget Resolution. Clerk Wright requested to move \$3,000 from the Electric Expense to Administration Expense. Mrs. Carolyn Teter thanked Council for the continuation of funding for the public transit program at Services for Seniors. Funds will be used to assist with their public transit program. Councilman Britz requested a quarterly report showing ridership numbers. With no further comments Mayor Fabian adjourned the budget hearing at 7:06 p.m.

Mayor Fabian called the special meeting to order at 7:06 p.m. The following were present at roll call: Mayor Fabian, Councilmen Graves, Ashenhurst, Madsen, Britz and Clerk/Treasurer Candy Wright.

Mayor Pro-Tem Madsen led the Pledge of Allegiance.

Mayor Fabian presented the agenda to Council for approval. Councilman Graves motioned, seconded by Councilman Madsen, to accept the agenda as presented. Motion passed 4-0.

UNFINISHED BUSINESS: Mayor Fabian presented, for third and final reading, Ordinance 818 an Ordinance Amending Wheatland Town Code § 8.15.020 (b) (1) (g) & §8.15.020(c) (1) (d) Establishing Use Restrictions and Fees for Disposal at the Wheatland Solid Waste Transfer Station (WSWTS). Councilman Britz motioned, seconded by Councilman Ashenhurst, to approve Ordinance 818. Motion passed 4-0. Ordinance follows in its entirety:

ORDINANCE NO 818

AN ORDINANCE AMENDING WHEATLAND TOWN CODE § 8.15.020 (b)(1)(g) & §8.15.020(c)(1)(d) ESTABLISHING USE RESTRICTION AND FEES FOR DISPOSAL AT THE WHEATLAND SOLID WASTE TRANSFER STATION (WSWTS)

BE IT ORDAINED BY THE TOWN OF WHEATLAND, WYOMING:

SECTION 8.15.020(b)(1)(b) is hereby deleted.

SECTION 8.15.020(c)(1)(d) is hereby amended to read as follows:

- (d)(i) Construction Waste & Debris deposited shall be charged the sum of \$ 80.00 per ton.
- (ii) All other materials deposited at WSWTS not described in § 8.15.020 shall be charged the sum of \$ 45 per ton.
